### American Canyon Arts Foundation Board of Directors Meeting Minutes – March 12, 2019

CALL TO ORDER: Secretary/Treasurer Mark Joseph called the meeting to order at 7:15pm.

- 2. <u>Board Member Comments</u> Roberta thanked the Oro Family for their help.

#### **COMMITTEE REPORTS**

- 1. <u>Community Support:</u> Chalk Art Event. We clarified the event is the same as prior years, but we weren't judging the artwork. The reason was it made the event more complicated, and usually, one or two of the winners never receive their award. Roberta reported she planned to use the Walmart gift cards to buy Bubbles for everyone. Call For Proposals School Grants. This was continued to the next meeting. Paint Day for the Kids. The Board agreed to work with the City to provide instructors and supplies for this event, tentatively scheduled for July 16 or 18. Our instructors would be paid, but not sure how much.
- 2. <u>Member Services</u>: **Pygmalion Art Contest**. We discussed the rules and timeline. We thought we would start promoting it in May or June, with a reception in August at the Welcome Center. We agreed to purchase approximately 30 sets of the oils. Roberta offered to translate the rules into Spanish, if necessary.
- 3. <u>Art Extravaganza</u>: We reviewed the status of the show and how to promote it. Jonette confirmed the three judges would be Robert Harris (substituting for Pam Jones, due to health issues), Charles White and Lynn Dykstra.
- 4. Mosaic Art Project: We discussed the fact that Anne Pentland of Nimbus was the primary inspiration for the work; but ACHS Senior Student, Yarra Bolla, contributed with her use of children. As a result, Mark motioned and Jonette seconded, to pay Anne Pentland \$500 and Yarra Bolla, \$100 for the design of the mosaic. Motion passed. We noted we would announce the winners at the City's Spring Celebration on March 23, and that would also be our first "tiling" event. We wanted as many members as possible to attend, since part of the goal is to train us on how to work with the tiles.

### **AMERICAN CANYON ARTS FOUNDATION Board of Director's Policy Manual**

#### Mission, Vision and Values Policy

Adopted/Revised:

2019

#### I. Purpose/Intent

Every organization needs to be clear regarding its mission, vision and values. These concepts define the organization and explain why that organization exists. The American Canyon Arts Foundation (ACAF) exists to support the arts and artists in American Canyon and the entire Bay Area.

#### **II. Policy**

#### **Section One: Mission Statement**

The mission of the American Canyon Arts Foundation shall be to maintain, enhance and support the role of the arts in American Canyon and the greater Bay Area; to familiarize the public with the recreational, cultural and economic significance of the arts; to encourage and promote local artists; and to provide financial and other assistance to the arts in our public schools.

#### **Section Two: Vision Statement**

The Vision of the American Canyon Arts Foundation is to become a vibrant, thriving art center that is self-sustaining, financially rewarding for artists and a cultural asset for the community.

#### **Section Three: Values**

The values of an organization define how that organization wants to conduct itself in business and in the community; they represent the principles that drive that organization. In short, they reflect the organization's culture.

- 1. Creativity: As an organization dedicated to the arts and artists, creativity is an essential element. Creativity is needed to interpret the world around us and transfer it to a canvass, sculpture or photograph. Creativity distinguishes the arts from merely recording events and images.
- 2. Collaboration: ACAF understands that it cannot achieve its mission by itself. Rather, we must partner with civic and community groups, other art organizations and the general public if we are to be successful. Collaboration means we learn from others, as well as use the strength and resources of others to succeed in our own endeavors. It also means we need to be prepared to extend a helping hand to our partners when needed.
- 3. **Dedication:** The history of ACAF is a story of constant struggle and perseverance. We have survived, not because we have a large following or patrons with deep pockets; rather, it has been based on the hard work and sacrifice of our members. For years we have made it on very little, and now that we are becoming more organized and professional, we need to remember that tenacity and dedication. We need to realize that dedication is a strength that will keep us in good times and bad.

4. **Service:** We are a support group for artists, but we are also a part of the community. We need to give back as much as we ask in support. Service is more than how we handle fellow artists and customers or patrons; rather, it should permeate the organization and be reflected in our dealings with other organizations and the community at large.

#### **Section Four: Work Plan**

The ACAF Board of Directors should develop a work plan that addresses our expectations over the next 2-5 years, in the areas noted below. This work plan should be updated annually and reviewed on a regular basis.

- Governance: This includes not only reviewing our By-Laws and Policies for any revisions or additions; but also, our relationships with government, community groups and other art organizations. Governance also addresses board make-up and the mission of ACAF, and membership issues.
- 2. **Fund Raising**: Fund raising is a critical aspect of any nonprofit. This area covers not only fund raising events which may also serve to reinforce ACAF's mission, but also letter writing campaigns and the search for sponsorships. Fund raising can also include new forms of revenue, such as grants and service fees that contribute to ACAF's operations.

**Program Operations**: The focus of the Foundation will change over time. Defining our key areas of focus, such as service to artists or support to the community, should be addressed. Specific programs, services or events should be identified and included, along with specific strategies for success. Membership benefits should also be included in this area.
